LETTERS WRITTEN AND PETITIONS SIGNED BY AVA-BERLIN

♦ In mid-February, efforts to re-name a central square in Berlin provoked this letter from AVA Berlin (written by Phil Hill):

An: Die Bezirksverordnetenversammlung Charlottenburg-Wilmersdorf von Berlin Die Fraktion der CDU in der BVV Charlot tenburg-Wilmersdorf

Sehr geehrte Damen und Herren:

Die CDU-Fraktion stellt laut Presseberichte in der BVV den Antrag, den Joachimstaler Platz in "Ronald-Reagan-Platz" umzubenennen. Als in Berlin lebende US-Amerikaner/innen bitten wir Sie dringlichst, dieses Anliegen fallen zu lassen bzw. nicht zu entsprechen. Die CDU-Fraktion erwähnt zwar die Frage auf ihrer Homepage mit keinem Wort, aus der kurzen Begründung des Antrags ist aber zu entnehmen, dass die Rede, die der damalige US-Präsident 1987 vor dem Brandenburger Tor hielt, in dem er den Staatschef der Sowjetunion Gorbatschow aufforderte, "dieses Tor aufzumachen, diese Mauer abzureißen", ihm zu einer solchen Ehre berechtige: Sie habe die "Diskussion um die Beseitigung der Berliner Mauer wieder belebt und die damalige Sowjetunion auf ihre Verantwortung für die deutsche Teilung aufmerksam gemacht."

So richtig die Forderung, sie war weder besonders originell noch wirksam: Weder war die Mauer von der Öffentlichkeit akzeptiert worden – jede/r Mauertote rief Empörung hervor! – noch hatten die Sowjets die Sache einfach vergessen. Nicht wegen dieses Stücks Kalter-Kriegs-Rhetorik, sondern aus eigenem Reformwillen und dem Wunsch, ein friedliches Zusammenleben in Europa zu ermöglichen, hat Gorbatschow die Maßnahmen eingeleitet, die zum Fall der Mauer führten. Gorbatschow, nicht Reagan, gebührt die Ehre. Auch die Menschen in der DDR, die letztlich die Mauer aufmachten, sind nicht erst durch Reagan auf diese Idee gekommen.

Im Gegenteil: Reagan hatte in den vorausgegangenen Jahren alles getan, um eben diese friedliche Annäherung unmöglich zu machen, v.a. mit der Raketenstationierung in Westdeutschland. Hätte die Sowjetunion so regiert wie gehabt, der Kalte Krieg wäre wieder in die Minusgrade gerutscht, stattdessen hat der neue, besonnene Staatschef in Moskau nicht wegen sondern trotz der Handlung seines Gegenübers den Frieden eingeleitet. Das haben die Menschen hierzulande auch damals verstanden: Gorbatschow wurde bei Deutschlandbesuchen – West wie Ost – behandelt wie ein Rockstar, Reagan musste seine Rede vor ausgesuchtem Publikum halten.

Doch eins hat Reagan für Deutschland getan: Nach einem Jahrhundert der Konkurrenz zwischen diesen beiden technologischen Spitzenindustrieländern hat die USA unter seiner Ägide das Handtuch geworfen und Deutschland das Feld überlassen, die USA desindustrialisierte sich und wurde zum "Finanzplatz" – mit den inzwischen bekannten Folgen. Deutschland geht es, dank Reagan ohne Konkurrenz, ganz gut, uns weniger. Wenn also eine Ehrung, dann

The current war on public sector workers and their unions now taking place in Wisconsin, Ohio, Indiana and a growing number of other states is not about fiscal responsibility, financial prudence, or balancing budgets. Indeed, as public sector workers in Wisconsin have already agreed to make the sacrificial concessions necessary to meet these goals, it is clear that the rhetoric of fiscal responsibility is a ruse to mask the true intentions of the rabidly anti-union, anti-worker far right and its corporate sponsors.

The American trade union movement has historically been the most significant institutional force in advancing progressive social change. Trade unions have played the pivotal role in making middle-class American life a reality. Equally important, unions have consistently used their significant resources to protect the public good when confronted with profit-driven, opportunistic forces. These forces seek to privatize public assets and make profits from the essential public functions that support the quality of life of mainstream Americans.

The current onslaught against public sector workers and their unions is both politically and economically driven. The goal of Governors Walker, Kasich, and others who share their extremist ideology is not only to destroy the one organized base of power that continues to fight against the corporate agenda, but also to undermine the very foundation of middle class life. These governors seek to destroy the major impediment to the privatization of public sector services. Their vision is a world in which voiceless and powerless workers are marginalized and their benefits drastically reduced while private entities become richer as they draw from the public till.

We are Americans who live in Berlin, Germany. Although overseas, we care deeply about our country. We believe that this war against the unions is really a struggle between competing and radically different visions of what America should be – an America whose democracy is grounded in a solid, broad middle class or a draconian alternative in which the middle class is destroyed and money dominates the political process. Our choice is obvious – not because of any ideological predisposition, but out of a recognition of the longterm positive importance and stabilizing economic influence of unions in America, for which there is overwhelming and irrefutable empirical evidence.

Because we live abroad, we are able to observe other societies where workers have a collective political and economic voice in health care and educational issues, where labor unions have an accepted role in creating a society that is economically healthy, a society for all its members. Capitalism is alive and well in Germany, but the social safety net has been defined differently than it is in the United States. The point is not to turn the U.S. into Germany or any other European nation. But from here we see that as long as viable unions exist, the political table can be set for all members of society, rather than only for the moneyed few. We believe that the defense of the public sector workers, their unions and the emergence of a strong labor movement in the United States are critical to protect a genuinely democratic vision of America.

To this end – to protect the rights and way of life of public sector workers, to protect and ensure a real democratic vision of America – and in the hope that the political debate might truly be broadened, we rise in support of our brothers and sisters in Wisconsin, Ohio, Indiana and elsewhere in the U.S. We believe unequivocally that American democracy is only possible when working people have a collective voice, a strong labor movement, and a vibrant and growing middle class. United for these principles, we are all Wisconsin. We are all Ohio. We are all Indiana.

2) And from Prof. Joe Salmons at University of Wisconsin via CAROL PFAFF: "Hurrah!!!! That's cool. I'll print some color copies and put them up around. Thanks! The big effort now is toward the recall of some key Republican senators. And we have a supreme race coming where a victory could be key to future court decisions. It's much appreciated. Please pass on word that stuff like this matters deeply to people here. We're aware of the national implications and when people are exhausted from marching in the cold and sleeping in the Capitol on the marble floors and so on, just knowing that we've got such broad support really helps keep people going. Thanks to you and everybody."

♦ At the June Stammtisch, AVA-Berlin heard from representatives of JedeStimme2011 who came to talk to us about their project: "Ausländerwahlrecht in Berlin einführen – für eine stärkere Demokratie" and the symbolic elections for Berliners without German citizenship that are to run parallel with the Berlin Abgeordnetenhaus elections this fall. (Thank you, Lisa Pettibone!) <u>www.jedestimme2011.de</u>. Here is a quick summary of the project in German taken from the Jede Stimme 2011 site:

Rund 470 000 Menschen in Berlin haben keinen deutschen Pass. Diese Menschen leben und arbeiten hier, zahlen Steuern und sind wie alle anderen von politischen Entscheidungen betroffen. Wählen dürfen Menschen ohne deutsche Staatsangehörigkeit aber nicht. Rund 14% der Berliner Bevölkerung sind somit von den Wahlen zum Abgeordnetenhaus ausgeschlossen.

Nach Vorbild der U18-Wahlen veranstalten die Initiatoren eine symbolische Wahl für MitbürgerInnen ohne deutschen Pass. Hierfür werden unmittelbar vor den Wahlen im September 2011 Wahllokale in Berliner Bezirken aufgebaut.

Mit diesem Projekt verbinden wir zwei Ziele:

1. Zum einen wollen wir bei Menschen ohne deutsche Staatsangehörigkeit mehr Interesse für Politik, die einzelnen Parteien und die Wahlen wecken. Bereits die Vorbereitung und Durchführung der Wahlen durch angeschlossenen Vereine und Kooperationen selbst soll diese Menschen dazu motivieren, sich bürgerschaftlich zu engagieren und sich so am demokratischen Gemeinwesen zu beteiligen.

2. Zum anderen ist es unsere Absicht, in der so genannten Mehrheitsgesellschaft eine breite Diskussion über die Möglichkeiten politischer Teilhabe von Menschen ohne deutsche Staatsangehörigkeit sowie über das Wahlrecht zu initiieren. Eine solche – längst überfällige – Debatte verstehen wir auch als einen Beitrag zur Belebung der Demokratie in Deutschland.

Als "Wahllokale" möchten wir alle Vereine, Einrichtungen und Institutionen gewinnen, die bereit sind, in der Woche vom 29. August bis zum 4. September an (einem oder mehrere Tage) Ihre Türen für dies symbolischen Wahlen zu öffnen.

And so AVA-Berlin volunteered to organize a symbolic voting booth as one of the many around the city. Ours was at Sprachwerk, DEBORAH COHEN'S language school at Solmsstr. 30 in Kreuzberg: <u>http://tinyurl.com/74m77ej</u>. Thank you, PAM SELWYN, for doing the organizing.

♦ Ava's Transatlantic Green Salon, our Berlin-American forum for dialogue on sustainability issues, was launched over a year ago on October 7, 2010 with Europe Energized? at the Freie Universität Berlin. U.S. political writer Steven Hill and German Green Hans-Josef Fell discussed the challenges of sustainable energy policy – and politics – in the U.S. and Germany.

Who is Ava? Call her the figurative grande dame of the salon, organized by ISABEL COLE. You can read all about it at <u>http://avasgreensalon.wordpress.com</u>.

"Ava" is a spin-off of AVA (American Voices Abroad) – Berlin, founded in 2003 by U.S. citizens in Berlin to protest the Iraq War. Since that time it has come to serve as an informal forum for Americans (and Germans) to learn about and discuss U.S. politics and policy. Ava's Transatlantic Green Salon continues this tradition of critical yet non-dogmatic discourse.

Ava's highlight of 2011 was the August 16 salon, New Ways to Measure Human Prosperity – Beyond GDP. The salon was kindly hosted by the Ecologic Institute, an international think tank for environment and development, whose resident experts Lucas Porsch and Tanja Srebotnjak opened the evening with presentations on basic GDP issues.

AVA's own RICH ROSEN, Senior Fellow at the Tellus Institute in Boston, "began by explaining the relationship between 'indicators' and an 'index': an index is an aggregate of different indicators. The difficulty lies in the fact that the indicators need to be weighed against each other and thus need a common unit of analysis. The advantage of GDP is that it has a very clear unit of analysis - money. Other than that, he argued, GDP is completely useless, as it only measures consumption and investment and is blind to sustainable development. (Particularly within investment, the GDP does not distinguish between good investment dollars that help us achieve sustainability, and bad investment dollars that make things worse.) One key issue is that an index cannot simply allow trade-offs among its indicators (as we did when distributing our 100 points) - some factors simply must be limited or they will reach dangerous thresholds. No single index will suffice; in a complex system, each indicator must be looked at separately." Lisa Pettibone from the FU Berlin's Environmental Policy Research Center moderated the panel discussion that followed.

♦ Last year, in late November, AVA-Berlin and Ava's Transatlantic Green Salon sponsored Gasland at the One World Berlin Film Festival. Josh Fox's documentary "gives voice to the bitter controversy surrounding 'fracking,' an unconventional form of natural gas drilling "There were interesting developments in 2011 regarding the film, as Alternet reports: "When the gas industry sent an open letter this month (February 2011) to the Academy of Motion Picture Arts and Sciences demanding it revoke its best documentary nomination for the gas-drilling exposé Gasland, many seemed surprised by this brazen missive. Gasland director Josh Fox wasn't one of those people. What this points to is the culture of that industry, which is bullying, which is aggressive, which is outlandish in their

tactics, which will stop at nothing, Fox told Alter-Net during a nearly hour-long interview. The Oscar nomination, of course, ensures wider attention to the dangers of the natural gas drilling process called hydraulic fracturing, or fracking, on our nation's water supply, air quality and overall impact on citizens' health." Gasland didn't get the Oscar but *Inside Job* (about the financial crisis) did.

♦ This November's film, *Granito: How to Nail a Dictator* (USA 2010,), directed by Pamela Yates, deals with the Guatemalan massacres of the 1980s. "Part political thriller, part memoir, Yates transports us back in time through a riveting, haunting tale of genocide and returns to the present with a cast of characters joined by destiny and the quest to bring a malevolent dictator to justice." The film was excellent and the Q & A afterwards with director Pamela Yates and producer Paco de Onis was impressive. Thank you, PAM SELWYN, for organizing the selection of the film, and thank you, ANJA-NA SHRIVASTAVA, for moderating the Q & A.

♦ As a sort of prequel to the film, CAROLYN PRESCOTT showed her paintings based on Stephen Kinzer's book *Overthrow*, an analysis of American-sponsored regime change. These small, narrative paintings make use of the traditional genre of Latin American retablos "to envision and make concrete historical events that seem distant and abstract." ♦ On November 15, AVA-Berlin (DAVID MACBRYDE) and Democrats Abroad (MICHAEL STELZER) organized a discussion via Skype with Tom Hayden in California.

This experiment using the Internet for a discussion — to exchange information and insights on what is happening in the U.S. – was moderated by ANJANA SHRIVASTAVA.

♦ At the December Stammtisch, we organized a photo shoot to show solidarity with Move-On and its "99% Congressional Speak-Out" on December 1st at the local offices of U.S. representatives and senators! Even though we don't have our own member in Congress, we spoke out in solidarity with the Occupy Movement from here. KAREN AXELRAD took the official photo that we sent to Move-On.
